

COVID-19 Declaration Form and Release

Due to the outbreak of the novel Coronavirus (COVID-19), KEONI is doing everything we can to protect our customers, our community, and our staff. To this extent, KEONI will be following the Center of Disease-Control (CDC) with regard to social distancing practices and sanitation.

Main symptoms:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

The enrolling family agree to the following:

- I understand the aforementioned COVID-19 symptoms.
- I have also informed my child on COVID-19 symptoms.
- I affirm that neither my child, nor any member of my household, currently has or has experienced the aforementioned symptoms within the past 14 days. Furthermore, I will immediately inform KEONI and discontinue classes if my child, or any member of the household, develops any of the aforementioned symptoms.
- I affirm that neither my child, nor any member of my household, has been diagnosed with COVID-19 within the past 30 days. Furthermore, I will immediately inform KEONI and discontinue classes if my child, or any member of my household, is diagnosed with COVID-19.
- I affirm that neither my child, nor any member of my household, has knowingly been exposed to anyone diagnosed with COVID-19 within the past 30 days. Furthermore, I will immediately inform KEONI and discontinue classes if my child, or any member of my household, is knowingly exposed to anyone diagnosed with COVID-19.
- I affirm that neither my child, nor any member of my household, has traveled outside of the country or to any city considered to be a "hot spot" for COVID-19 infections within the past 30 days. Furthermore, I will immediately inform KEONI and discontinue classes once my child, or any member of my household, returns from traveling outside of the country or to any city considered to be a "hot spot" for COVID-19 infections.
- I understand that the KEONI cannot be held liable for any exposure to the COVID-19 virus caused by any misinformation on this form or the health history provided by each Student.

KEONI will be adhering to the following enhanced procedures to prevent the spread of COVID-19.

Our staff will:

- Do a temperature check before entering the center, and ensure that it is below 100.4°F.
- Clean/Disinfect frequently touched surfaces thoroughly and at regular intervals.
- Wash/Sanitize our hands before and after each session.
- Wear our masks at all times.
- Maintain a safe distance at all times.
- Accommodate a limited number of students in each class to ensure physical distancing.
- Schedule classes so as to allow time for cleaning/disinfecting surfaces and allow students to finish and leave the center before the next set of students arrive.
- Provide sanitizers in the reception area and other locations within the premises.

We are requesting that each of our students:

- Allow us to check their temperature before entering the premises to ensure it is below 100.4°F.
- Wear a face mask at all times within the building and within the center.
- Maintain a safe distance from others at all times.
- Use the hand sanitizer before entering and while exiting the center.

Parents:

- Please use the front entrance to drop off your child.
- Please use the back door to pick up your child.
- We are no longer allowing people to hang out in the front lobby. Please wait outside for your child.
